Subject:	Informational Update: Medicare Improvements for Patients and Providers (MIPPA) funding allocation

DAS's Office of Community Partnerships will receive \$102,410 in federal funds from the Medicare Improvements for Patients and Providers (MIPPA) program for a term running September 1, 2024 through August 31, 2025.

DAS will accept this funding through the Memorandum of Understanding (MOU) that this Commission approved in May 2024. That MOU allows DAS to enter into contract with the California Department of Aging Services to accept multiple grants for the administration of Older Americans Act (OAA) services.

## Background

## Services to be provided

The MIPPA program provides assistance with Medicare beneficiary enrollment in the Prescription Drug Benefit Low-Income Subsidy program, the Medicare Savings program, and Medicare Part D. The grant also promotes an expansion in outreach activities related to preventing disease and promoting wellness.

## Grant

MIPPA services will be administered through San Francisco's Health Insurance Counseling and Advocacy Program (HICAP). San Francisco's HICAP is operated via a grant from DAS's Office of Community Partnerships to Self-Help for the Elderly, a local community-based organization. Staff will bring that grant to the Commission should it need any modifications in the future.

### Year over year comparison

This year's allocation is \$25,811 higher than its predecessor.
