**Subject:** Annual Homeward Bound Report, FY 2023-24

In accordance with [Ordinance 069-24](#), this memo provides an annual report of relocation services provided by the Human Services Agency (HSA) and Department of Homelessness and Supportive Housing (HSH). The following programs are included in this report:

- **Journey Home:** Offered by HSA and HSH as part of the Drug Market Agency Coordination Center (DMACC) for unhoused people and people with substance use disorders. This program started in September 2023.
- **CAAP Relocation Services (HSA):** Provides travel assistance to new applicants and existing clients in County Adult Assistance Program or CAAP, which is the City’s general assistance program that serves indigent adults. This service was launched in April 2023 to expand on HSH’s relocation services.
- **Problem-Solving’s Relocation Assistance (HSH):** Supports people experiencing homelessness (including people about to lose their housing) with income up to 50% of the area median income. Launched in July 2022 as a successor to the longstanding Homeward Bound program.

Please note, four metrics are unavailable for the FY 2023-24 reporting year due to lack of data. This ordinance passed only a few months prior to the end of the fiscal year, and data systems did not contain all necessary elements to produce these metrics. HSA and HSH have updated data tracking systems and anticipate all metrics will be available in the FY 2024-25 report.
