Executive Director Dearman discussed the HSA Black History Month Celebration and talked about the invasion of Ukraine. City employees back to the office 2 days a week and masks can be taken off as of Monday 3/21/22. Report on the Conservatorship on the office of Budget new meetings next month. Update on Tenderloin Linkage Center, using data to focus on system change. American Rescue Plan (ARP) DAS will receive just over 3 million for nutrition programs, family support, and planning. One time fund and must be used by Sep 2024. Many questions from Council Members about meal options and public availability of conservatorship meetings.

New Business

Adithi Velore works in the planning unit of HSA and presented the Annual Update of the Area Plan 2022-2023. Changed the Public hearings section of the report- Focused on the technology section addressing concerns of Adv Council members on the digital divide. Updated DAS ORG Charts to show changes. Unanimous vote to approve this.

Marie Jobling from the CLC presented the Keeping us Connected Campaign. Report on the Needs Assessment and taking this presentation around the city. Focused on the digital divide for seniors and people with disabilities. Surveyed over 3000 people with over ½ living in San Francisco. It was very accessible. Majority were older age seniors aged 60+ along with younger people with disabilities. Key findings: 64% respondents cited that technology was a barrier to receiving vital services. Keep us connected campaign (Pandemic Edition).

Committee Reports

• **Joint Legislative Committee:** Diane gave an update on the Joint Legislative Committee with Allegra. CSL provided Bills that will be up for approval next month. Most are part of the Master Plan. 2 Bills, AB848 – to increase the needs allowance for Medicare recipients from \$35 to \$50. Asking for Council approval in form of a letter, motion was approved.

Allegra talked about Bill AB2483 – jurisdictions to allow medical resources for housing for assisted living facilities and unhoused seniors and people with disabilities. Motion to write the letter

approved. Senior Rally Day is May 3rd and virtual this year. Open seat for the Dignity Fund, Advisory Council, and CLC that are being sought after at the moment.

Proposal to fill the 2 positions to appoint President Lawrence and Dr. Juliet Rothman to the Dignity Fund Oversight and Advisory Committee, unanimous vote to approve.

• **Dignity Fund Oversite and Advisory Committee Update:** Marcy did not give an update this month because she was an excused absence

Reports from the field Dr. Juliet Rothman quickly gave an update and asked Council Members to do site visits for next month.
