Why do you need to attend the HSA Community Meeting on the Budget?

- The City is currently projecting a **\$45 million** General Fund shortfall in FY09-10 and a **\$522.2 million** General Fund shortfall in FY 10-11. The Mayor's Office will propose a significant reduction in the Department's General Fund support.
- The meeting will provide community members and non-profit organizations with an update on the City's funding projections and an opportunity to weigh-in on strategies to reduce Department costs.

What topics are going to be covered?

- FY2009-10 mid year reductions, Mayor's Office budget directives, economic forecasts, and spending plans.
- Potential service changes and program restructuring in divisions throughout the Department.



## **DISABILITY ACCESS**

The Born Auditorium, on the first floor at 170 Otis Street has accessible seating for persons with disabilities (including those using wheelchairs). The closest accessible BART Station is at 16<sup>th</sup> and Mission Streets. Accessible MUNI Lines are the 14-Mission, 49-Mission/VanNess, and 9-San Bruno. All the MUNI Metro Lines are accessible.
